BALLOT ISSUES ON NOVEMBER BALLOT

I. CONSTITUTIONAL AMENDMENT 3 (Proposed by the General Assembly SJR 51)

This Amendment involves a non-partisan court plan regarding the way we select Missouri Supreme Court and Appellate judges. A "yes" vote will amend the Missouri Constitution to change the current nonpartisan selection of supreme court and court of appeals judges to a process that gives the governor increased authority to appoint a majority of the commission that selects these court nominees. This measure also allows the governor to appoint all lawyers to the commission by removing the requirement that the governor's appointees be non-lawyers.

A "no" vote will not change the current constitutional provisions for the nonpartisan selection of supreme court and court of appeals judges. If passed, this measure will have no impact on taxes.

Please vote YES!

2. PROPOSITION A

The law would be amended to allow any city not within a county (the City of St. Louis) the option of transferring certain obligations and control of the city's police force from the board of police commissioners currently appointed by the governor to the city and establishing a municipal police force

A "yes" vote will amend Missouri law to allow any city not within a county (the City of St. Louis) the option of establishing a municipal police force by transferring certain obligations and control of the city's police force from the board of police commissioners currently appointed by the governor to the city.

A "no" vote will not change the current Missouri law regarding St. Louis City's police force.

Please vote NO!

3. PROPOSITION B

Proposition B was placed on the ballot by an Initiative Petition. This Missouri law would be amended to create the Health and Education Trust Fund with proceeds of a tax raised from the sale of tobacco products, and putting it into a Health and Education Trust Fund.

A "yes" vote will amend Missouri law to create the Health and Education Trust Fund with proceeds from a tax on cigarettes and other tobacco products.

A "no" vote will not change the current Missouri law regarding taxes on cigarettes and other tobacco products or the escrow account and bonding requirements for certain tobacco product manufacturers.

If passed, this measure will increase taxes on cigarettes and other tobacco products.

Please vote NO!

4. PROPOSITION E

Proposition E is a law that would stop the governor or any state agency from establishing or operating state-based health insurance exchanges (essentially ObamaCare) unless authorized by voter approval or by the legislature. It was placed on the ballot by the Missouri Legislature.

Please vote "YES."
